First settled around 1820, Magee began with the arrival of brothers-in-law Arthur Mangum and Phillip Magee, who moved with their families from North Carolina. They purchased land and were soon joined by more pioneers from the Carolinas and Virginia. In 1840, Willis Magee, son of Phillip, built a gristmill on Little Goodwater Creek inside the present city limits.



The Community grew steadily and was incorporated as a village on February 25, 1900.

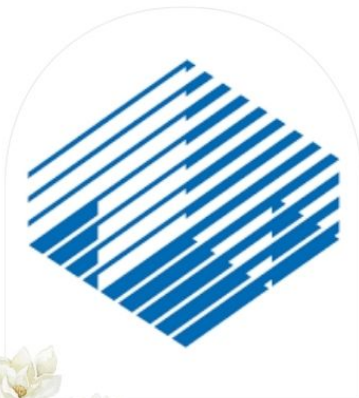

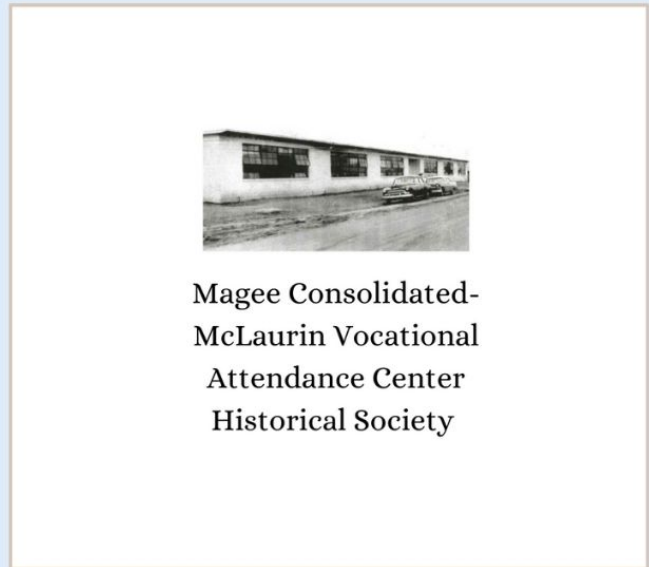
