#### **DIMENSIONAL VARIANCE:**

A Dimensional Variance from the terms of the City of Magee Zoning Ordinance, Section 2504, as amended, shall not be granted by the Planning Commission until the Applicant has demonstrated that the following conditions are met:

- A. That special conditions and circumstances exist which are peculiar to the land, structure, or building involved and which are not applicable to other lands, structures, or buildings, in the same district.
- B. That literal interpretation of the provisions of this Ordinance would deprive the applicant of rights commonly enjoyed by other properties in the same district under the terms of this Ordinance.
- C. That granting the variance requested will not confer on the applicant any special privilege that is denied by this Ordinance to other lands, structures, or buildings in the same zoning district.
